APPLICATION FORM FOR BLUE AND GOLD ALUMNI SCHOLARSHIP

This scholarship is designed for an EHS student or recent graduate (within 5 years of graduation) interested in pursuing an associate's degree or certification from Surry Community College (or other community colleges). Scholarship applications are accepted beginning January 1 and must be received by April 1.

- Anyone who graduated from Elkin High School or was a dual-enrolled student with an accredited college or university is eligible to apply. Students must apply within five years of their graduation date and must not have received a bachelor's degree during the five-year period.
- 2. Scholarships are awarded for two years.
- 3. Students will receive a minimum of \$500 per semester capping at \$1000 annually.
 - The EEF board, upon recommendation of the Scholarship Committee, will determine future awards based on financials provided by the EEF Finance Committee.
- 4. All scholarship recipients must maintain a 2.0 GPA and be attending school full-time (as identified by their program) to receive their scholarship benefits. EEF Blue and Gold Scholars will email a copy of their semester grades to the EEF Executive Director as soon as the semester grading is completed.
- 5. Scholarships will be given to students who are pursuing a vocational or technical degree or other associate degrees. Any student or alumnus who meet the requirements are eligible for scholarships and are encouraged to apply.
- 6. All applicants must complete the FAFSA application and submit recommendation forms from two individuals (as described on the form), a copy of their resume, a copy of their high school transcript, and the completed scholarship application by the April 1 deadline.
